
O'Neal Industries has added a custom illustration to our branding materials – a magnolia tree, which you will see throughout this report. This illustration represents the magnolia tree that was planted in 1942 outside of the old office at O'Neal Steel in Birmingham. Over the years, the tree grew and developed with the company, and when in bloom was a thing of rare beauty.

In 1974, when O'Neal Steel moved into its new office, Chairman Emmet O'Neal, son of our company's founder, wanted to save the tree and move it across the street in front of the new office. Experts said it couldn't be done – that the tree wouldn't survive, but Mr. O'Neal said to move it anyway. It took two 60-ton cranes to lift and move it over two hundred feet, roots and all, to its new location. With care and attention that tree is still there today, strong as ever.

The deep roots and reaching branches of the magnolia tree continue to inspire us every day at the O'Neal family of companies. The sense of what has passed and what is to come keeps our extended family of co-workers and communities moving forward together.

Our company's founder, Kirkman O'Neal, had a Latin phrase he liked to use: Difficultas ne deterrem, which means difficulties do not deter us.

And they don't.

Social Services 14-15

Organizations designed to promote the basic physical and material well-being of people (basic needs such as food and shelter).

Social Equity 16-17

Organizations that promote equal economic, political, social rights, and character-building; help create the conditions/ opportunities for the success of all people; and eradicate chronic injustice against a minority group of citizens.

United Way 18-19

To improve lives by mobilizing the caring power of communities around the world.





Arts & Culture, Civic and Conservation

Jefferson County Greenways Foundation encompasses Red Mountain Park, Ruffner Mountain, and Turkey Creek Nature Preserve. Ruffner Mountain: Saved from development in 1977 by a community nonprofit, starting with a small group committed to preserving 24 acres. Turkey Creek Nature Preserve: Formed in the 1990s to prevent a jail construction and clean up the creek, officially protected in 2008 with support from Freshwater Land Trust and Alabama Forever Wild Program. Red Mountain Park: Initiated by community effort in 1999 to reclaim the abandoned No.11 Mine, officially reclaimed in 2012 by the Red Mountain Greenway and Recreational Area Commission.

In each instance, citizens and community leaders recognized the importance of maintaining publicly accessible land.

Grundy County Historical Society Heritage Center in Grundy County, Tennessee, is a library and research center containing thousands of books, maps and genealogical resources and a museum with permanent exhibits depicting themes of history that grew out of the plateau that have had national or international impact.

The mission of Grundy County Historical Society Heritage Center is to inspire all of the people and communities of the South Cumberland Plateau, its coves and valleys, to understand who they are and how they are connected in history with interrelated pathways.

Red Mountain Theater (RMT) is a nonprofit theatre organization that supports artists, provides educational programs for youth, and engages audiences through theatre.

RMT offers a variety of theatre-based educational opportunities for young people, including the RMT Youth Ensembles. Through participation in theatre, students enhance their creative and collaborative skills, as well as build confidence. These skills are beneficial both on stage and in other areas of life.

Education

Teach For America (TFA) exemplifies a profound dedication to educational equity and excellence. By enlisting and developing the nation's most promising future leaders, TFA works tirelessly to ensure that all young people recognize their own potential and have the opportunities to realize it. Through initiatives such as the teacher corps, Ignite Fellowship, and alumni programs, TFA builds transformational relationships that inspire and empower students and leaders alike, regardless of their initial background in education.

Jones Valley Teaching Farm (JVTF) uses food to empower young people, helping them create a healthy future for themselves and their community. JVTF operates vibrant outdoor learning spaces called Teaching Farms on school campuses. Through experiential lessons during school, after school, and at home, students explore academics, leadership, and career pathways using food, farming, and culinary arts.

Jefferson State Community College's Center for Workforce Education delivers fast-track skills training designed to quickly train individuals for immediate employment. Its full portfolio of non-credit training covers IT, manufacturing, CDL/driving, craft training, and business sectors and is ever evolving to accommodate the needs of employers in the state of Alabama.





Health

aTeam Ministries is an organization dedicated to providing spiritual, financial, and emotional support to children and their families dealing with pediatric cancer. The organization assists these families through various programs, including prayer teams, Home Away from Home lodging, financial grants, and a range of events and activities. It consists of volunteers who aim to offer support and compassion as families navigate this challenging journey.

Susan G. Komen Breast Cancer Foundation was founded forty-two years ago by a sisterly promise which ignited a fight against breast cancer. Focused on risk reduction, early detection, and innovative treatments, the Foundation has contributed to a 42% reduction in mortality.

Susan G. Komen invested nearly \$3.6 billion in research, community health, advocacy, and programs across 60+ countries, leading to the approval of 19 new drugs in the past decade. Its vision remains a world free from breast cancer.

Turning Point provides a safe, peaceful environment for men recovering from substance use disorder. Their program is a residential 12-Step Immersive Experience with a Christ-centered focus. It promotes a spiritual solution to substance or alcohol abuse in a supportive community. The campus offers a serene environment where the residents can focus on healing and recovery without distractions.

Social Services

American Red Cross plays a crucial role in hurricane and tropical storm relief by stocking supplies in preparation for hurricane victims and establishing safe shelters for public safety. They provide shelter and food until families can return home, offering guidance, hope, and comfort to the community. Moreover, they provide medical care for anyone in need, distribute clean-up supplies, assess damage in impacted neighborhoods, and work with families in developing comprehensive recovery plans.

Ronald McDonald House Charities (RMHC) is a non-profit organization that supports families of children who are sick or injured. RMHC provides various programs, including Ronald McDonald Houses, Family Rooms, and Care Mobile programs. It assists families so they can stay close to the hospital and helps reduce stress and financial burdens. The home-like facilities offer a free place to stay for as long as necessary.

Isaiah 117 House offers a safe and nurturing environment for children awaiting placement after being removed from their homes due to safety concerns. Instead of waiting in a child welfare services office, which can take several hours to days, children are brought to Isaiah 117 House where they receive physical and emotional support. The house staff provides clean clothes, toys, and comforting items, ensuring the children feel safe and cared for while child welfare staff finds suitable placements.





Social Equity

The Exceptional Foundation offers comprehensive year-round social and recreational services for individuals with intellectual disabilities. Our programs are designed to promote healthy living, enhance life skills, foster social relationships, and encourage community participation. We provide full-day programming for adults, alongside after-school and summer programs for children. Established in 1993, The Exceptional Foundation aims to address the social and recreational needs of individuals with special needs, filling gaps not covered by educational institutions or the broader community.

Renew Birmingham is actively involved on the ground, investing time, energy, intellectual resources, and funds to support neighborhoods. Along with partners, it aims to address issues such as violence, substance abuse, poverty, and blight, aiming to improve conditions for vulnerable residents. External intervention often has limited success in revitalizing underserved neighborhoods. Effective change requires initiatives from within the community. Residents are empowered to collaborate to revitalize their communities and enhance their quality of life for sustainable change.

The Boys and Girls Club of Oshkosh, Wisconsin aims to improve the lives of children and families. For over 50 years, it has offered a safe space for youth to learn and grow. The Club provides quality programs, mentoring by caring professionals, and excellent facilities. Serving over 3,000 youth, the Club helps young people reach their full potential through safe environments, supportive adults, and engaging activities.



United Way Hands On's mission is to connect people with organized and meaningful volunteer opportunities to help bring about positive social change. In 2024, more than 3,000 volunteers donated over 12,500 hours of hands-on service.





O'Neal Employee Disaster Relief Fund

O'Neal Industries established the O'Neal Employee Disaster Relief Fund in 2012, which is supported by monetary gifts from O'Neal Industries companies and our employees. The goal of the Fund is to provide short-term financial assistance to employees of all O'Neal Industries companies who have been affected by fires, natural disasters, or other catastrophic events. When financial hardships arise, the Fund helps ONI affiliate employees, as well as provides a way for co-workers to help one another. Employees who have been impacted will be contacted by the HR Partners at their companies to ensure that they know about this fund and how to make requests.

The need for assistance must stem directly from:

- A natural disaster, such as a devastating flood, ice storm, hurricane, tornado, or fire
- A short-term personal emergency like a house/apartment fire or flood resulting in a loss of basic needs such as food, clothing, or shelter
- A catastrophic event such as the death of an employee or family member or sudden illness or injury that causes an unforeseen financial circumstance

Awards of assistance will be made based on financial need and the severity and impact of the disaster on the named applicant and his or her family. Employees must have a minimum of 90 days of service with the company in order to be eligible for assistance. Supporting documentation and signatures will be required.

Donations

This fund is a 501(c)3 organization, and it is supported by monetary gifts from the company and our employees. A critical component of the fund is to be assured that there will always be money available whenever disaster strikes. Employees may make a one-time donation, or we are allowing employee payroll deduction - you may contact Human Resources Partner to sign up for payroll deductions to make contributions each pay period. You may not designate a specific party to be the recipient of the funds that you donate – all distribution decisions are made by the employee committee.

If you would like to donate to the fund, you may make checks payable to "O'Neal Employee Disaster Relief Fund" and send them to your company representative, or directly to the Fund Treasurer:
